### **INVITATION TO BID FOR THE SUPPLY OF MATERIALS FOR THE REHABILITATION OF SIMINLONG IRRIGATION MAIN CANAL, ZONE 6, SAN PEDRO, BUHI, CAMARINES SUR (BUHIGOODS202605-004)**

The Local Government of Buhi, through the **20% Municipal Devt. Fund 2026** intends to apply the sum of **FIVE HUNDRED FOUR THOUSAND TWO HUNDRED EIGHTEEN & 40/100 PESOS (Php 504,218.40)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **SUPPLY OF MATERIALS FOR THE REHABILITATION OF SIMINLONG IRRIGATION MAIN CANAL, ZONE 6, SAN PEDRO, BUHI, CAMARINES SUR**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Local Government of Buhi now invites bids for the **SUPPLY OF MATERIALS FOR THE REHABILITATION OF SIMINLONG IRRIGATION MAIN CANAL, ZONE 6, SAN PEDRO, BUHI, CAMARINES SUR**. Delivery of the Goods is required by **thirty-nine (39) days**. Bidders should have completed, at least (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rule & Regulation of Republic Act 12009 otherwise known as the New Government Procurement Act. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from the Local Government of Buhi and inspect the Bidding Documents at the address given below from Monday to Friday, 9am to 4pm.

A complete set of Bidding Documents may be acquired by interested Bidders on May 19 – 29, 2026 from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos (Php 1,000.00)**.

The Local Government of Buhi will hold a Pre-Bid Conference on **May 19, 2026 at 9:00 AM at Municipal Budget Office, New Municipal Building, San Buenaventura, Buhi, Camarines Sur** which shall be open to prospective bidders.

Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below, on or before **June 1, 2026, 9:29 AM**. Late bids shall not be accepted.

All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

Bid opening shall be on **June 1, 2026 at 9:30 AM at Municipal Budget Office, New Municipal Building, San Buena, Buhi, Camarines Sur**. Bids will be opened in the presence of the Bidders' representative who choose to attend the activity.

The Local Government of Buhi reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of the Implementing Rule & Regulation of Republic Act 12009 otherwise known as the New Government Procurement Act, without incurring any liability to the affected bidder or bidders.
